Money Matters

As an organisation owned and run solely by volunteers, Steyning Museum has to cover its own running costs. We have to rely entirely on the generosity of the Friends to provide an income from the annual subscription and activities such as coffee mornings, the Museum shop sales, and profits from activities such as concerts. We also keep an eye on how we can reduce running costs. The solar panels on the roof have been very successful in

reducing the electricity bill, but you may have noticed that all the old light fittings have now been replaced with LED fittings and this has already led to a reduction in consumption costs.

There is also another source of money which we now wish to increase. Some of you no doubt are aware that organisations such as ours are able to claim "Gift Aid . This is a scheme whereby we can claim back 25% of your subscriptions from the government if you are a taxpayer

Erica Gayler, our subscription secretary, has provided a piece overleaf to explain the scheme and there is a separate form attached to the newsletter for you to sign so we can claim that refund from the government. PLEASE SIGN AND RETURN THE FORM EVEN IF YOU ARE NOT A TAX PAYER.

Dear Museum Friend,

A valuable addition to Steyning Museum's income is our ability to claim back from HMRC 25 per cent of the subscriptions/donations you make to us, providing you have completed a Gift Aid Declaration. This means, for example, if you have paid a £5 subscription we can claim an additional £1.25 from HMRC. This does not affect your own taxation.

Over the years, the rules and the declaration forms have changed.

One of the major changes is that in the past we could accept a single signature to claim on a joint subscription made by a husband and wife. Now, if you pay a joint membership subscription each of you must sign a separate Gift Aid Declaration.

We appreciate that you may have completed a Gift Aid Declaration in the past, but we would be very grateful if you could please complete a new one (to be found overleaf) and hand it into the Museum addressed to the Subscription Secretary.

We are asking all Museum Friends to complete the Declaration whether they are a tax payer or not. There is a section on the form to make a it clear if you are not eligible to claim Gift Aid. We will not then have to trouble you again thinking that you have forgotten to return the form.

We hope that you will be able to complete this form as soon as possible which will enable us to make an accurate claim for 2015/2016 tax year.

A new Constitution for the Museum – it's here!

We've got a great change coming up on which we would like all members of the Friends of Steyning Museum Trust to come and vote on at the AGM.

Until now The Steyning Museum Trust has been an unincorporated association. It was registered as a charity in February 1984. Its trustees are the management committee which is elected every year by the Friends of Steyning Museum. This form of charity has serious shortcomings in the modern world – it cannot enter into contracts or hold property, or protect its trustees against action.

It was decided in 2015 that we should update our constitution by registering as one of a new form of incorporated charities set up under the Charities Act 2011. I wrote an article explaining the proposal which was circulated to all members in the February 2016 newsletter. As I reported in the December 2016 issue, the new Charitable Incorporated Organisation (CIO), with the same name, The Steyning Museum Trust, was registered on 10th October. Its constitution is on the Museum website (see the Friends page, under the heading "constitution".) A hard copy is available for consultation in the Museum.

Five members of the current management committee (Muriel Wright, Helen Coutrouzas, Chris Tod, Paul Norris and Sarah Leigh) were registered as the initial Trustees of the new body.

At the AGM we will be asking the Friends, as the membership of the original Museum Trust, to pass a resolution authorising the Management Committee to transfer all the assets and liabilities of the Museum to the new CIO and in due course to wind up the original Trust. We are asking the Friends to elect a new Management Committee to carry out this task.

Members of the original charity (the Friends) will not automatically become members of the new one, but will soon be asked to sign up to become one.
